

Mota Ghrainne Oige (Moate)

Moate is an important market town on the main Dublin/Athlone/Galway road and situated in the Centre of a rich cattle-raising area. The Gairbh-Eiscir (rough esker) running almost parallel with the Moate/Mount Temple Road is a noteworthy feature of the District. The town takes its name from the remarkable mound of Mota Ghrainne Oige which rises behind it. Ghrainne Og was the wife of O'Melaghlin, Chief of the District, who resided here. The ruins of the sixteenth-century castle of the family can be seen two miles from Moate where many interesting archaeological finds were made in 1932 when 'Crannog' site (Lake Dwellings) were excavated near the town. Moate is one of the homes of Irish music, the local branch of 'Comhaltas

Annual Report 1989

"You see things as they are; and you ask Why?". But I dream things that never were: and I ask 'Why not?'. George Bernard Shaw - Irish Emigre.

The prophetic is a necessary component of any balanced, mature organisation. It always seeks to explore beyond the formal limits, to push new frontiers of understanding, to raise new questions, and to challenge the formal structures to be ever on the alert to respond to new needs. Without the prophetic, the institutional would become rigid and stale, expanding a maximum of energy on its own self-perpetuation. The task of the prophetic is to challenge the institutional into new ways of being, of acting, of relating and communicating with humanity. Its task is to criticise any form of systematic domination and to energise people into creative co-responsibility.

The fundamental cause of homelessness is the huge gap between low incomes and the cost of housing. The problem is most acute in urban centres, in particular London, but is also being felt in rural areas as daily commuters and people buying holiday or retirement homes push prices well above the means of most locals.

Homelessness is growing most rapidly among young people, especially 16 and 17 year olds who are largely in-eligible for income support since the government tends to assume that they will either be in employment or on YTS placements. For many young people unable to find a footing in society by way of a job and a place to live, homelessness is virtual inevitability. There is also an increase in mentally-ill people on the streets, undoubtedly attributable to a great extent to the move away from long-term institutional care for the mentally-ill towards community care. According to one survey, around 25% of those discharged from psychiatric hospitals had no accommodation to go to.

Although rising mortage interest rates over the past few years have generated an increasing degree of homelessness among house buyers — already 10% of homeless households cite inability to keep up with mortgage repayments as the reason for losing their home — homelessness is a feature mainly of the rented sector. This, in effect, means local authority and housing trust schemes, as private rented accommodation now accounts for only 10% of total housing supply versus more than 90% in 1918. Among the single homeless is a high proportion of members of ethnic minorities, especially black, Asian and Irish.

While homelessness has been on the increase for some 30 years, the rise has been particularly sharp since 1982, fuelled mainly by the combination of the systematic selling off of council housing stock to local authority tenants and sharp cutbacks in new building. In the mid-1970's, local authorities built well over 100,000 houses a year. Current output is around 15,000 and is set to be cut to 6,000 a year by 1991-92. It seems highly unlikely that any increase in output later in the decade will be enough to close the gap. (Housing Association dwellings are projected to rise from 15,000 a year in 88-89 to 40,000 by the mid-90's)

A comparison between the UK and six other north west European countries shows that although Denmark, France, Germany the Netherlands, Norway and Sweden have all reduced capital spending The UK needs to allocate substantially more funding to house building. On housing as a proportion of gross domestic product during the past two decades, all have consistenty spent more on housing than the U.K. In 1987, these six countries spent an average 4.7% of GDP on housing (Germany and Norway spent 5.1% and 5.2% respectively). While the UK figure was 3.7%. One report points out that if Britain's new building expenditureas a percentage of GDP during the 1980's had been on the same scale as Germany's, more than 600,000 additional houses would have been built.

Clearly, to go any way towards combatting homelessness as part of a long term strategy, the UK needs to allocate substantially more funding to house building. But there are also a number of short term options open to government and local authorities: in May 1988, London boasted some 23,000 vacant council dwellings, of which just over one-sixth were available for letting; empty dwellings in the private sector totalled close to 100,000. Officials in various welfare agencies are pressing for vacant housing, owned not only by local authorities, but also by housing associatons and even the private sector, to be made available in order to alleviate this critical problem.

Community Services Report

1989 was another busy year for this department, The Centre interviewed 4,500 callers and answered 8,400 telephone enquiries. These 13,900 persons presented assorted problems totally 23,055.

Thirty one percent of our clients requested help with identification difficulties. In the majority of cases identification would have been required for the Department of Social Security.

Our main response to these queries would be to send for a Birth or Marriage Certificate. Since the recent benefit changes, Irish people making fresh claims for Income Support face extreme difficulties unless they have a number of forms of official identification (including a Birth Certificate) to support their claim. The staff frequently dealt with people who were refused payment of Income Support despite having a Birth Certificate.

Employment advice and assistance is a service availed of by twelve per cent of clients. The majority would have requested assistance in obtaining labouring work on building sites. This reflects the immediate needs of clients, as labouring work is seen as easily accessible to young unemployed Irish, and payment is usually in cash at the end of the week. Information is provided on site safety and alternatives to labouring work, such as courses run by Migrant Training Scheme or at skill centres, and callers are encouraged to use the phones in the centre to try and get work. Help with travel costs is given, when necessary to get to work the next morning.

Our second-hand clothes store and shower facilities were used by up to six per cent of clients. These were particularly welcomed by the homeless or those living in squats, who wanted to prepare for an inteview or just restore some self pride.

Repatriation is often a very lengthy process. Staff have to contact friends/relatives in Ireland to guarantee payment of the fare before we can arrange a travel voucher. Refusal to guarantee payment means we are unable to repatriate a person, so we then have to look at other ways of obtaining help.

Changes to the Social Security System

1989 was yet another year of changes to the Benefit System. For the bureaucrats this system is now more effective and easier to administer, but for the claimants, claiming benefit has become a time consuming bureaucratic task that is almost impossible to comprehend.

The first stage in claiming benefit is to sign on as available for work at the Unemployed Benefit Office. This used to be a relatively straightforward task, but in March 1989 the Unemployment Benefit Office and Job Centres were merged into

one. Every new claimant must now be interviewed by a 'New Client Adviser' who works by appointment only and claimants often have to wait up to 5 days for an appointment. Claimants who have not worked and paid National Insurance contributions in the U.K. must claim a means-tested benefit called Income Support. The claim form is issued by the New Client Adviser if he/she is satisfied with the interview.

Then comes the second stage, bringing the claim form to the D.S.S. Here the claimant has to prove their identity by providing documentation that satisfies the officer at that particular office, very often two forms of identification are necessary. Income Support is paid two weeks in arrears, the D.S.S. can issue a crisis payment in the form of a loan but this is very rarely given to single people. Before April 1989 this would be the end of the procedure for people living in Board and Lodgings, or Hostels, but now as the D.S.S. no longer pay accommodation costs to these claimants

they have a further hurdle to cross. They have to make a separate claim to the Local Authority for Housing Benefit. This involves a great deal more form filling and sometimes an even longer wait for payment.

This is the change that has had the greatest effect on our work with clients. Before April 1989 (October 1989 for Hostels) people living in Board and Lodgings or Hostels could receive extra money for meals to cover the costs of eating out. Now these claimants receive the basic rate Income Support from the D.S.S., the rent element of their accomodation costs plus eighty per cent of the rates element are paid by Housing Benefit. They have to pay extra charges (e.g. meals, service charges etc.) from their Income Support. Thus the majority of these claimants are worse off.


