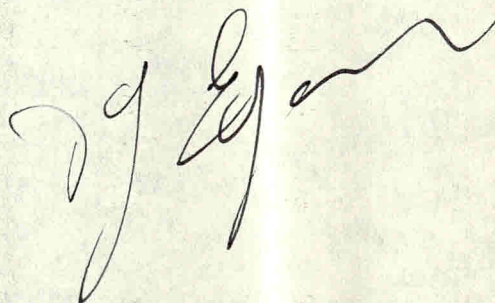
FUND RAISING
