3. MATTERS ARISING : None

4. FINANCE REPORT : Sales for the first six months showed a small surplus however expenditure on wages, repairs and renewals absorbed the insignificant increase of '490. It was agreed that a monthly financial statement should be produced and presented to the committee at their monthly meeting.

Sunday lunches proving satisfactory and clientele increasing thereby providing much needed revenue for the catering unit.

Premises cleaning not satisfactory and it was recommended that two full time persons be employed to include a man to cope with heavy work. It was agreed that each revenue area must be subjected to critical analysis to ensure maximum productivity and profit as there is no room for loss leaders in view of our heavy financial commitments.

Wembley concert not a great success due to clash of dates and programme content not of a high calibre.

Relocation of offices is going ahead hopes for completion in about six weeks. Chapel is next on the plan and will be transferred to old office location in due time.

WELFARE REPORT : Paul Murphy is on holiday and Fr Scully gave a full and comprehensive report.

Concern expressed with regard to an assault on staff. Co\_ordinator to keep a sharp eye to the matter and report any incidents to management for appropriate action.

Continuing to monitor in coming phone calls.

Hostels full to capacity. Leaflets distributed to clients with regard to health and safety on building sites.

Discussion on Poll Tax collection re Hostels and the meaning of "Short Stay" hostels. Clients receive housing benefits from local authority from 9 October. Possibility of a sponsor to fund Annual Report is being investigated.

DIRECTORS REPORT : Fr Scully

Insurance claim re Kennedy not yet settled. All refurbishment should be completed in about four weeks, new lights due soon with new switching system Douglas Hyde Lounge will also be re-decorated when everything is complete and all carpets, curtains etc will be cleaned.

Training scheme going well and has expanded to 10 computers.

Licence Renewal will be heard on Oct 10th. The authorities need sight of Title Deeds presently held by commercial credit. Our solicitors are processing the matter.

Loan agreements with commercial credit over 15 years repayments amount to £2,600 per month. A.I.B. offer of charges 2% over base \_ still looking at other sources.

Reception in main entrance has to have radiator installed.
