FINANCE REPORT Socials & Dances

The Administrator advised the Committee that no Receipts have been received from Bands performing for The Irish Centre Club and it was proposed that administrative procedures be put in hand with immediate effect so that all Bands performing at the Club would provide a written acknowledgement of monies received with Name, Address and Signature of Band Supervisor. This was agreed by the Committee. It was also agreed that the Administrator consult with the Chairman of COIC with respect to settlement of Function Accounts by COIC as there is sometimes a delay of months in this issue.

Bank Mandates

The Committee were advised briefly that due to the reconstruction of The London Irish Centre Charity viz as between London Irish Centre Charity (Charity Division) and London Irish Centre Limited (Trading Division) new Bank Accounts had to be opened the latter being operative as from 1st January 1990. It was proposed by J Myers and seconded by T Mangan, all present assenting that two Current Accounts and two Deposit Accounts be opened with Allied Irish Banks Flc, Holloway Branch and designated London Irish Centre Charity Welfare A/cs and London Irish Centre Charity Development and General A/cs respectively. It was also proposed that an Account be opened with the Bank of Ireland, Holloway Branch designated London Irish Centre Limited. The necessary documentation with signatures to the Bank mandates forms were then completed.

A meeting of Trustees of London Irish Centre Charity was arranged to take place on Friday 15th December at 1.00 pm in order a) to receive approval and authorization of the Trustees for the current restructuring of London irish Centre Charity and b) to update Trustees on the process of reconstruction of the Charity and the motives—behind the change.

A meeting was held at the instigation of the Chairman and Director with Mr Michael Walshe, a Security Supervisor, and some hours were spent in discussion with Mr Walshe the latter emphasising a number of inadequacies in the security systems operating at the Centre. It was suggested that an alarm device be installed close to the goods entrance together with a number of other recommendations. It was agreed that a meeting be called with staff members on individual basis with Mr Walshe and this meeting is scheduled to take place on Thursday 21st December 1989.
