Welfare Report: Presented by Christine. Copies circulatee including statistical review July/August. Gender Statistics July 379.

Aisling Report: Recognition of contribution by Irish Centre noted.

Fundraising calendar September/October included. Chair thanked Christine who then left the meeting.

Fr. Jerry: in follow-up noted that this particular Aisling trip was not properly acknowledged. Two staff members accompanying the trip were paid by LIC x 2 weeks. Considerable preparation, underappreciated by welfare department.

D. Egan: Said Welfare consider it their own energy.

M. Allen: Admin Cttee. not consulted informed only of action. Fr. Jerry: said there is tension in the office. 1996 should be done in consultation, not denying the advantage of such a trip.

D. Egan: suggested an extract from the Admin Minutes should be forwarded to Welfare for agreement by Admin Cttee by 31st March. This was agreed.

Rev. Phelan: asked what areas clients are from. This is not known.

Fr. Jerry: Welfare Advisory Committee members should be put together by the Admin Cttee. Request in writing to the Cttee and appointments by them.

It was agreed that following the AGM - the advisory cttee should be named: item mentioned at the AGM.

Rev. Phelan: stated the "New Age" issue is a serious problem referring to recent shows at the LIC.

Fr, Jerry: the Psychie show was a 'one-off' and considered light entertainment and not afffecting morality.

Regarding the Gay/Lesbian event: M. Allen noted LIC is franchised to Saxon Inns in consequence we have no control.

D. Egan: referring to Constitution Clause "The Christian Aspect" asked members whether we should create an awareness or ensure management is informed.

T. Reilly: said there is a difference between the two events.

Fr. Jerry: we cannot make moral judgments.

D. Egan: I would be uncomfortable moralising we need a balanced judgment and member attendance is minimal at this meeting.

M. Allen: we cannot instruct management on Gay/Lesbian issue, there is a legal aspect.

D. Egan: is such franchises are regular, it could cause problems.

Rev. Phelan: continued that an appeal in Ireland thought to be for LIC by parishes was for the London Chaplaincy: considerable donations collected.

Fr Jerry: is aware of this.

Minutes of the previous meeting having been posted to members were adopted on the proposal of M. Allen, seconded by T. Reilly. One correction as noted by Rev. Phelan: his initial is T. not J. Phelan.

Matters Arising: Chairman reported the issue of noise pollution from the building. Objections to Licence Renewal were forthcoming. Measurements had been taken as agreed. The appointed working party as per previous minutes met 8th August 1995 - It was a good meeting - various options were looked at.

Peter Fitzpatrick's contribution very objective. No pre-set vision on his part. He has known the LIC. A further date needs to be considered including Fr. Pat Carolan. The issue is great and needs time.

It was agreed that sufficient notification at the AGM would be that we are looking at the matter - a review is taking place. Fr. Jerry: Two options

- 1. Brady/Malleliew plan.
- 2. Emerging Consensus: in support of P. Fitzpatrick ideas.

T Platt would like to meet the group.

D. Egan: we are heading in the direction of radical conclusions, at the point of admin. structues and building. AGM attendants should be aware of progress - A stark reality facing us. Fr. Jerry: we are in the process of clarification. Revelation only at AGM we are looking ahead to the future.

5. Director's Report

Photocopier: on-going communication. Difficulty since we owe £4,000 + VAT = £5,000. This final offer - Reduction Net by £1,000. Pay or legal action.

T. Reilly: as previously advised, stop payment. Let them take the machine. In excess of £6,000 already paid. A legal representative in session on Saturday. Tony suggested seek his advice. Fr. Jerry to see him. Three months notice had already been given.

Social Committee: re: New Year night. A disagreement between social committee and Ceilidhe group: DH Lounge - Social Committee agreement the right to use the hall on important nights annually.

T. Reilly: it should be a joint effort. A recommendation from the admin. committee.

Famine Remembrance: stands and literature forthcoming.

40th Celebration: Talk by Fr. Paul Byrne OMI 7.30pm. Buffet: "Tribute to the navvies" Music cost £1,000 allocation for grant not yet responded to.

Maintenance: £370 repairs to cooling system MacNamara Hall. Half accepted by Saxon Inns. Total =£740. Refrigeration our responsibility. Kitchen roof, flat roof leaking due to hot weather affect.

Music classes - Monday, Thursday evenings. Dancing Saturday AM. Irish Language: Friday night. Saturday Morning cancelled.

History Course: commencing 11th October 7.30pm £18 per term.

Meeting with AIB reps.

Niall Gallagher/David Petrie - interesting on their behalf, a commitment to be available, if any Irish people needing advice, would be happy to help.

Development of a strategic plan for LIC where one asks for grants - well packaged.

A mission plan needed: AIB will help with drawing up and publishing document.

D. Egan: queried inventory for LIC. Finbar Burke had been involved in preparation with Fr. D. Cormican.

M. Allen: noted that stainless steel items, cofffee pots etc were missing, even prior to Saxon Inns taking over. Checking in and out has fallen down.

Fr. Jerry: there is insurance against loss in Refundable Deposit, now completed. Fr. Jerry to investigate total amount paid. (It was £200 p.m. for 2 years)

Saxon Inns: on-going dispute about 2 weeks. Otherwise more or less on time. August not yet received.

Library Books: R. Scanlon, Hammersmith wants to develop a library. Can they borrow? It was agreed to refuse.

Race night: Caron Gallagher - receiver Grosvenor Rooms, Willesden has volunteered organisation of a race night at LIC proceeds to LIC. It was agreed to advise - LIC engrossed in Ruby Celebrations at this time.

Fr. Jerry: Referred to a parish group who had a buffet at LIC Cost £4 to them - their charge to customers, £10. Several complaints re food content.

Visit of President Robinson, 27th October '95.

Official opening of flats, St. Pancras Way, and Leighton Road, Kentish Town.

Buffet, Irish Centre 11.30 - 12 md.

Welcome by Admin Committee - formal by representatives.

D. Egan queried appointment of trustee prior to President Robinson as Patron.
