Dear Friends,

It would appear that W.H.Smith are responding positively to our continued pressure in that they are "reconsidering" their stock policy regarding the whole range of 'joke' books.

The whole saga has received a good deal of coverage and support notably from the Irish Post and Haringey Council's leader Mr Bernie Grant.

Not only have we contented ourselves with paper action but on December 14th Haringey I.B.R.G., supported by members of other Irish Community Groups staged a picket and disrupted trade at W.H.Smith'S in Wood Green London N22.

The Wood Green branch no longer stocks the offensive joke books, but whilst this can be seen as a temporary victory it is only a small one in view of the many branches of W.H.Smith that still find space for these racist books on their shelves.

It is in this context that we must realize that victory can only be truly claimed when W.H.Smith irrevocably change their policies and cease the sales of these offensive 'joke ' books nationwide.

This will not come about by just a few people in Haringey and elsewhere critcising W.H.Smiths racist stance and their policies of selling material, that denigrates Irish people by reducing them to negative stereotypes. Although W.H.Smith have told us that that they have received letters of support for these anti-Irish joke books from within the Irish community. We maintain that to support this questionable form of humour, is to promote the same negative stereotypes and poor self image that Britain has continually employed as a means of justifying it's interference in Irish affairs for the past 800 years.

W.H.Smith& sons have repeatedly hidden behind their defensive statement "We are not censors". In view of the nature of the many controversies surrounding their stock over the past years, (Gay News, Private Eye etc.) few people could take this defence seriously.

As for their suggestions that we should complain to the publishers, (Futura/Macdonald fiction, Maxwell House, Worship Street EC2. owned by Robert Maxwell )it should be obvious that these books would not be printed unless there were large commercial outlets available who were prepared to sell them for a profit, i.e W.H.Smith & Sons Ltd.

#### W. H. Smith rebuffs Irish complaint

The newsagency chain W. H. Smith is to continue selling anti-Irish books, despite a complaint by Bernie Grant, the leader of Haringey borough council in north London.

Cllr. Grant invited the management of Smith's to meet him to discuss its policy of stocking books such as The Official Irish Joke Book and The

Irish Kama Sutra.

But now he has received a letter from the company's managing director, Malcolm Field, who says: "Part of our responsibility as booksellers is to fulfil the legitimate demands of our customers and part is that we do not set ourselves up as

censors.
"While we have no wish to cause offence, it is inevitable that all viewpoints cannot be pleased all the time. the Irish joke books "are simply books of humour and of course humour is a matter of personal taste. Some may not find these books amusing, but very many others, including many Irish people, find them harmlessly funny".

Malcolm Field also claims to have received telephone calls from several Irish people urging Smith's to continue stocking the joke books, with one woman stating that "the Irish are proud of their sense of humour'

Cllr. Grant wrote to Smith's after members of the Irish community in Haringey com-plained to Haringey Council. The council's ethnic minorities committee then considered the issue and condemned the production and distribution of production and distribution of racist literature, with specific reference to "so-called" joke books, posters and such like which belittle and ridicule Irish people and Irish culture".

Expressing his disappointment at the reaction by Smith's, Cllr. Grant said: "Racism against the Irish is just as insidious and evil as

Irish is just as insidious and evil as against any other ethnic group. The fact that its usual form is so-The fact that its usual form is so-called jokes means that a lot of people might not take it as seriously as they should. Haringey Council is totally opposed to racism in all its forms and we shall be doing what we can to ensure that the sale of this offensive material stops".

Books chain rejects criticism

The IBRG has accused the newsagency chain w. H. Smith of "promoting racist material" by continuing to stock anti-Irish joke books, despite repeated complaints from the Irish community, writes CAROLYN QUINN.

The IBRG wrote to W. H. Smith requesting that the company review its policy of stocking such books as The Official Irish Joke Book and The Irish Kama Sutra, claiming that they degrade and insult Irish people.

But, in a reply, W. H. Smith's managing director, Malcolm Field, says that they do not intend withdrawing the books from their branches. He recalls his reply at the close of last year to a similar request from Bernie Grant, the leader of Haringey Borough Council in north London. "There has been no change in our views since I wrote that letter", he says.

His letter to the IBRG goes on: "I should perhaps add that the sales of these books clearly indicate that there is a public demand for them, notwithstanding the fact that they are not on sale at all our branches, very little shelf space is devoted to them and we do not actively

sale at all our branches, very little shelf space is devoted to them and we do not actively promote them. Our role as booksellers is to try and make available books for which there is a

public demand. Perhaps you would think it appropriate to address your complaint to the publishers of these books, rather than to the booksellers?"

In its complaint, the IBRG asked why W. H. Smith is not stocking Liz Curtis' book Nothing But The Same Old Story, which deals with the history of anti-Irish racism in the British media. Malcolm Field has replied saying that they have no knowledge of the book but that if the publisher approached them they would consider stocking it. Responding to the reply from W. H. Smith, the IBRG's PRO, Patrick Reynolds, says they will continue their campaign to have racist Irish joke books banned and are urging all concerned Irish organisations and individuals to write to Malcolm Field at W. H. Smith's headquarters in London's Holbein Place. in London's Holbein Place.

"W. H. Smith say that they do not set themselves up as censors. That will be news to many. We accuse them of being partial to books which stereotype and degrade Irish people, while ignoring the classics of Irish literature", Patrick Reynolds said.

In fact what it reveals is a deep rooted ignorance and an unwillingness to accept other cultures.

Anti-Irish prejudice is deeply embedded in English culture and is a direct result of the Imperialistic relationship between the two countries.

#### ANTI-IRISH RACISM

I am writing to you at the request of Irish representatives of the community in Haringey with regard to the stocking of material in your. Wood Green Branch which they regard as offensive and racist. I am sure you realise that we live in particularly sensitive times sofaras race relations are concerned and I would ask you to examine critically your Branches policy with regard to this.

In Haringey we have an Ethnic Minorities Joint Consultative Committee and it was at the previous meeting (30.10.85) of that Committee that the following resolution was passed:

"In keeping with this Council's anti-racist policies this Committee condemns organisations and individuals who produce and/or distribute racist material. In particular, we condemn those who produce and/or distribute so-called 'joke' books, posters, etc., ridiculing and belittling Irish people and Irish culture. In the interests of racial harmony we demand that such practices cease forthwith".

The representatives inform me that they have approached the Book Manager and Shop Manager in Wood Green Branch before with regard to this but have failed to get a positive response. Additionally a letter from the Irish in Britain Representation Group dated 19 November 1984 to Head Office to which you responded on 23 November 1984 produced an equally negative response.

I would ask to look again at your policy in this respect and would be pleased to discuss the Council's racial equality policies with you or your representatives at any time.

Thank you for your letter of 13 November. I am sorry if anyone thinks we sell 'racist' books - at our Wood Green branch or anywhere else.

We are very conscious of our responsibility as booksellers. Part of that responsibility is to fulfil the legitimate demands of our customers, and part is that we do not set ourselves up as censors. While we have no wish to cause offence, it is inevitable that all viewpoints cannot be pleased all the time. For example: at the same time as your Irish representatives accuse us of being racist, we are being criticised at the opposite end of the spectrum for selling the Institute of Race Relations' book, 'How Racism Came to Britain'.

The Irish books we stock are in no way racially motivated. They are simply books of humour, and, of course, humour is a matter of personal taste. Some may not find these books amusing, but very many others, including many Irish people, find them harmlessly funny. Indeed, following Press publicity about your letter to me, we were telephoned by an Irish lady, living in North London, who said the Irish were proud of their sense of humour, derived great pleasure from this type of book, and urged us not to consider taking it off sale.

I am grateful to you for writing, because I feel it is important to know the views of all sections of the community. But I cannot agree that these humorous books are 'racist', nor to give ourselves the role of self-appointed censors.
