BIAS - Working with Irish People

BIAS was established in 1978 as a not-for-profit organisation and we are now in our eighteenth year of operation. BIAS is a community development and service provider organisation which is non-party in politics and religion and which provides a practical, essential service to Irish people in North-West London and beyond. The large and diverse Irish community forms a substantial proportion of the resident population in London and is one of the Capital's largest national groups originating from a single overseas country.

With an ancient cultural heritage, combined with a modern lifestyle, Irish people who emigrated from their own country to find employment and make a new life have contributed much to the development of industry, commerce and services in Britain. Even to-day, as we move through the 1990's, young migrants still come to Britain to seek work and accommodation.

As foreigners in a strange land, many Irish people, especially those from rural and Irish-speaking backgrounds, may experience culture shock, alienation and racism. Some of them may have problems with housing, jobs, social security and welfare.

Within the Irish community, there is a disproportionate number of older Irish, people with disabilities and mental ill-health, and homeless people. There are also groups of Irish people who have particular needs, including women, young people, pensioners, travelling people and the unemployed. This is where BIAS comes in.

Chairperson's Report

BIAS' information, advice and support services continue to be well used by the Irish Community. As we move towards the end of the decade and a new millennium, the demand for BIAS' services as well as that of other Irish agencies across London and Britain, shows no sign of relenting.

In an era of strict financial budgets set by local authorities, health agencies and government departments, it is vitally important that the needs of Irish people are not only recognised but also met by these statutory agencies. Increasingly though, needs will only be met if they fall within the criteria of legislation that, for instance, governs community care, children's, and housing, services.

It is in such a climate in 1995 and 1996, of financial cutbacks and streamlining of services by statutory authorities, that BIAS has been able to successfully develop in partnership with local authorities and health agencies, in North-West London particularly and London-wide generally, a range of specifically commissioned services for Irish people.

BIAS is now contracted to provide services for children and families and older people within the Irish community. In the year ahead, we will not only be aiming to consolidate these achievements but also to build on them and to develop similar quality, professional contracted services throughout London. To enable us to achieve these goals, we have established a Community Services Team at new offices in Brent - this will give BIAS a springboard for developing into the future.

I would like to use the opportunity of this Annual Report to thank our funders for their continued support. I would also like to express my sincere thanks for all those individuals and agencies who have supported BIAS' work over the year, and in particular to offer my personal thanks to the staff team and to my colleagues on the Management Committee.

At this point, I would like to pay a tribute to a committee member who left during the year - Louise McKeon. Louise who left because of work commitments, played a significant part in helping BIAS develop to meet the challenges of contracted services. I wish Louise every success for the future.

London-wide Information and Referral Service Helpline

Achievements

The telephone helpline service dealt with 6,504 enquiries during the year. This represents a slight decrease in the number of enquiries compared to last year. The reduction undoubtedly reflects the reduction in the overall number of hours that the helpline service was open - BIAS reduced the opening times slightly to ensure a more efficient and responsive service to telephone enquirers.

Analysis of the number and nature of enquiries for 1995/96 revealed the following:-

- a) a continued increase (compared to last year) in the number of people seeking information and advice because of homelessness/housing need
- b) a significant increase in the level of enquiries from people, either having difficulties in obtaining the welfare benefits and services they were entitled to, or, requiring information on claiming new benefits such as the Incapacity benefit
- c) continued increase in number of enquiries from people (particularly people over 60) considering moving/returning to Ireland

The advice appointment service offered Irish residents of the Borough of Brent the opportunity to discuss individual queries with an advice worker at BIAS. Monitoring of the type and level enquiries at the advice sessions revealed the following:-

Children & Families Social Work Service

BIAS Community Services is contracted by the Children and Young People Commissioning Team of London Borough of Brent Social Services Department, to provide support services, under the Children Act 1989, to Irish children and families in need, in the borough. Under our current contract a direct referral can be made by Brent Social Services for work with Irish children and families who currently live in the Brent area.

During the past year BIAS Social Work Service provided the following services for the London Borough of Brent's Social Services Department:-

- Assessment work with or without London Borough of Brent Social Worker.
- Joint casework with LB Brent Social Worker.
- Family work, direct work, group work
- Consultancy on specific issues relating to work with Irish families
- Advocacy work representing the client /advocating on behalf of children

BIAS Children and Families Social Work Service worked with 27 families referred by the Social Services Department in the past year.

The work undertaken by BIAS involved dealing with issues such as:-

Child Protection, Joint Investigations with Social Services, facilitating Contact between the parent(s) and a child 'looked after' by the local authority, family work, advocacy and consultancy.

Housebound Visiting Service

Achievements during 1995/96

The team of voluntary workers managed by BIAS' Elders Community Care Worker continued to provide a housebound visiting service to isolated and frail older Irish people in Brent.

Support on a wide variety of issues was provided by the voluntary visitors - issues included, accessing community care services, using health services and taking part in Irish social and cultural activities.

For many of the older Irish people using the housebound visiting service, the worker from BIAS was often the main visitor, and therefore continued to play a crucial role in ensuring that any potential crisis (be it housing, health or income related) for the person being visited, could be quickly identified.

During 1995/96, 584 home visits were made.

New Developments for 1996

In 1996 BIAS will be developing a number of new projects in partnership with a range of statutory and non-statutory funders.

Irish Travellers Service

Travellers Health Access Project

BIAS Community Services have been commissioned by the NHS Ethnic Health Unit to work with Irish Travellers in the London Boroughs of Brent and Harrow.

The Health Access Project aims to improve Irish Travellers access to Primary health care services in the 2 boroughs.

Children's Project

BBC Children in Need have funded BIAS Community Services to develop play activities for Irish Traveller children in the London Borough of Brent.

London Borough of Harrow Research Project

BIAS has been commissioned by the London Borough of Harrow <u>and</u> Brent and Harrow Health Authority to research the community care needs and the needs of children within the Irish community in the Borough of Harrow.

Moving to Ireland Development Project

Financially assisted by the Housing Associations Charitable Trust and Age Concern England, this project will respond to the community care needs of older Irish people by developing greater opportunities for them to move to Ireland.

Equal Opportunities Policy

Statement of Intent

BIAS accepts that in society certain groups and individuals are disadvantaged and, as a result, the agency is committed to taking positive steps to redress the balance in terms of its employment practices and service delivery. BIAS also believes that passive policies in themselves do not provide equality of opportunity. BIAS has therefore committed itself to the task of establishing and implementing an effective Equal Opportunities Policy. In addition to the responsibility outlined above, BIAS also accepts the statutory requirements laid down by the Race Relations Act, the Sex Discrimination Act and the Employment Acts.

BIAS wishes to employ the most suitable staff and therefore intends to ensure equality of opportunity so that no person will be discriminated against, either as actual or potential employees, particularly on the grounds of race, nationality, religion, gender, disability, sexuality, class, marital status or unrelated criminal conviction.

BIAS is also committed to ensuring that it's services are accessible and safe to users of the agency. To this end, BIAS employees will actively work to ensure that this is the case, which will include challenging discrimination, abuse or harassment by individuals in contravention of this policy. Our interview offices are wheelchair accessible.

Responsibility

Each member of staff has a responsibility to work to implement this policy in all aspects of their work.

Recruitment

There is a separate recruitment procedure, a copy of which is available from BIAS' office.

Training

Staff will be made aware of training opportunities available to them, and will be positively encouraged to take these up. This will apply to all staff, whatever their position in the organisation. In particular, training will be provided in order to realise potential where formal qualifications and experience may be lacking.

Monitoring and Review

The Co-ordinator in co-operation with the staff team will provide an Annual Report on the implementation of this policy, analysing in detail failures and successes to the Management Committee. To assist in this process, all monitoring information on recruitment and service delivery which has been collated during the previous year, will be used and commented upon, and acted upon where necessary.
