

Inquiry Into Emigration

Report Launch

"Irish Emigration - A Programme for Action" is the title of the joint report by the AGIY and TIDE, the Dublin based Emigration Research and Action Group. This report presents the findings of two inquiries into emigration held in Dublin in 1987 and London in February of this year. It analyses the impact of contemporary emigration on Irish society and draws together the experiences and issues that affect Irish people in London.

The report makes a series of recommendations to authorities in Ireland, Northern Ireland, London and the EEC on how issues around contemporary Irish emigration might best be tackled.

The report will be launched in Dublin by Bernie Grant MP and an Irish politician at a press conference on Sunday 11th September 1988 at 11.30 a.m. in Buswell's Hotel, 25 Molesworth St., Dublin 2.

 Copies of the report which will cost STG £2 or IR £3 will be available from AGIY or TIDE from 12th September.

Young Irish People And The DHSS

social security changes on young Irish clients.

Questionnaires were distributed to young people using these agencies during the week commencing 25th July 1988. The AGIY is now in the process of analysing and interpreting the completed and returned forms.


The results of this exercise and their implications will be taken up with the DHSS and used to appraise agencies in Ireland concerned with pre-emigration welfare of the particular problems that young Irish people are experiencing under the new system.

National Lottery

Further contact has been made with the Department of Education in Dublin concerning the progress of funding applications to the Irish Government's National Lottery scheme by agencies working in London.

Civil servants have informed AGIY that due to the pressure of work and the holiday period the funding applications have not yet been processed. It now appears that an inter-departmental committee comprising of civil servants from the Department of Education, Labour etc. will be set up to examine the funding applications.

The membership and terms of reference of this committee have not yet been established and the Department of Education would not commit themselves to a timetable for processing the applications.

The AGIY were also informed that a decision to fund agencies working in Britain with National Lottery monies still had to be made.

£775,000 DHSS Money For Charity!

The Charities Aid Foundation (CAF) has been chosed by the DHSS to distribute £775,000 of funds to voluntary organisations in England assisting the unemployed, the short term sick and single parent families. The funds have been made available as a result of an error by the DHSS when the updating of social security benefits was carried out.

The funds will be distributed quarterly and grants will be for a minimum of £1,000 and a maximum of £50,000. This money can not be used for fixed assets or core salaries and expenditure of grants must not run beyond 31st March 1990.




