Census to omit Irish?

The Government is currently drafting trial census forms that may be used in the administration of the National UK Census in 1991. The Government proposes to include a specific ethnic group question which would help to provide information and data that would contribute to improving and developing new programmes aimed at overcoming racial discrimination and disadvantage.

The Government proposes not to include the Irish as a distinct category in the ethnic group question.

Instead the Irish as a distinct ethnic grouping will be submerged and hidden within the "white" category question. The consequences of this are twofold:

the loss of opportunity for a true assessment of the numbers of Irish people in Britain and the denial of data and statistics that would enable an overall assessment and description of the economic and social experiences of Irish people here. Independent research has proved that the Irish experience in Britain is one of disadvantage, particularly in terms of access to housing and employment. This experience of racial disadvantage will fail to be adequately identified if the current ethnic group question remains unchanged and will have serious implications for Irish community groups' attempts to secure statutory funding in the future.

Following the 1991 Census, the next Census will not be until 2001. Does the Irish community in Britain have to wait until the 21st Century before it can be counted and identified and can claim its rightful share of central and local government resources?

What can you do?

A campaign to amend the existing format and to include a distinct Irish category in the ethnic group question has been underway for some time. Travellers - New Initiative

The last meeting of the London Irish Youth Forum raised and discussed some of the issues and concerns affecting Irish travellers in London. A number of specific needs and demands as well as gaps in current service provision were identified and at a subsequent meeting between travellers and London statutory and voluntary sector workers it was suggested that an attempt should be made to co-ordinate and bring together the wide range of work and activities across London of travellers, individuals, agencies and support groups working with Irish travellers or interested in working with Irish travellers.

To this end an open meeting has been arranged for: Tuesday April 18th 1989 at 2.30 p.m. in the Douglas Hyde Room, Irish Centre, Murray Sq., Camden, London NW1. The meeting will look at ways of developing as an independent umbrella organisation coming together on a regular basis to exchange information and ideas and developing a co-ordinated response and strategy to travellers' issues in London.

Irish Youth Handbook



The ILEA Irish Youth Workers Group has recently produced a very useful and comprehensive handbook on "Youth Work with Irish Young People". The Handbook is compiled by ILEA Youth Workers based on their experience of face-to-face and contact work with both first and second generation young Irish. It includes a broad outline of the history and experience of Irish emigres to London and includes lots of information on the range of services available here to support work with Irish youth as well as suggesting good youth work practices. It also explains Irish educational and training qualifications and offers a comprehensive list of books, videos and additional materials useful for training and youth work discussion practices.

FAS distribute Guide to London

FAS, the Irish National Training and Employment Authority has just received 5,000 copies of A Guide to London for Young Irish People which they intend to distribute in Ireland through their national network of 80 offices in cities and towns.

This initiative has been taken by FAS as part of their responsibility in providing information to young people who may be considering emigrating to London.

To date the number of Guides distributed in both Britain and Ireland equals 14,999 plus one copy to Washington DC, USA making a grand total of 15,000!

- · deprived children,
- · the disabled,
- · other disadvantaged groups.

All monies raised in Britain by the event will be distributed to Irish welfare organisations working in Britain. Grants which will usually be made in the region of IR£2,000 - IR£10,000 will be directed towards smaller charities for specific non-recurrent projects. Funds will not be provided for recurrent revenue purposes.
