

# Are you actively seeking work?

From 9th October 1989 the Social Security Act has made major changes in the law on "availability for work". In addition to being available for and capable of work, unemployed people are now expected to demonstrate that they are taking reasonable steps to "actively seek employment" every week. If they fail to satisfy the Employment Service (ES) that they are taking reasonable steps they will lose benefit for the one or two week period in question.

The Act has also narrowed the grounds on which a claimant can reject vacancies. The onus is now on the claimant to show that they have "good cause" for turning down a job.

## How do claimants show that they are actively seeking work?

Claimants are now asked to keep a record of any visits (with dates) they have made to employment agencies and Job Centres, of newspapers or trade journals they have used to find vacancies and of any contacts they have made to look for work. They are also expected to keep

- job advertisements they have responded to
- letters from employers they have applied to
- and a record of their application letters.

#### **Interviews**

Claimants will now be subjected to regular interviews where their job seeking activities will be assessed. If a claimant's jobseeking activity is called into question they

will be given a warning letter which spells out up to five steps that they should take to look for work and told that they will have to come back for an "Actively Seeking Work Review" interview. This will take place within two or at most four weeks of their next signing day.

If the claimant fails to take the steps outlined or it is thought that the claimant is not "actively seeking" work benefit will be suspended for the one or two weeks in question and the case referred for adjudication.

#### **Benefit Penalties**

If benefit is suspended Unemployment Benefit will be stopped and Income Support will be reduced by 40% or 20% of the personal allowance. When a suspension for not actively seeking work takes place the claimant will be informed in writing and will be able to appeal against the decisions.

#### Refusing a Job

The Act now restricts claimants' rights to reject vacancies which are "unsuitable" on the grounds of their previous experience and training and it also says that "after a permitted period the level of remuneration (pay) will not be a good cause for claimants turning down or failing to take advantage of an employment opportunity".

### "Good Cause" for Refusing a Job?

There are some factors which count as good cause for refusing a job which include:

- the time it would normally take from home to work and back again;
- the expenses which would be incurred in the course of the employment.

In addition other matters will be taken into account and claimants may well be able to argue that their age or their state of home-

lessness, for example, makes a particular job inappropriate.

#### Implications of the New Rules

Although Employment Ministers have said publicly that they do not intend to make adult training and government employment training schemes compulsory it seems that the "actively seeking work" condition will make participation in such schemes an offer that many claimants cannot refuse. Young Irish claimants who already experience great difficulty obtaining access to welfare benefits are likely to be put through more hoops in order to qualify for benefit.

AGIY are particularly keen to learn how these new rules are being applied to Irish claimants. Details of such incidences can be forwarded in total confidence to AGIY.

### **AGIY in IRELAND**

### Galway Youth Centre

Following an invitation from Galway Regional Technical College SIMON Group, AGIY were represented last week at a seminar in Galway on the "Housing and Homelessness Situation of Irish People in London". In acknowledging the need for information and preparation by emigrants before leaving Ireland,

widespread concern was expressed when it was learned that the GALWAY YOUTH CENTRE is threatened with imminent closure due to lack of funds.

Last year (Sept. 88-Sept.89) Galway Youth Centre provided pre-emigration advice to 1,541 people which represented 32% of their total clients. Without further and immediate funding this service will be denied to many more young people.

### **Funding News**

## Irish Community Funding Awareness Conference

AGIY are organising a one day national funding awareness conference for Irish community/welfare/voluntary organisations on Wednesday 29th November 1989 in Rooms 10 and 11, Friends House, Euston Road, London NW1 2BJ from 9.30 a.m. - 5.00 p.m.

The purpose of the conference is to appraise Irish community organisations of the variety of sources of funding available to projects and to provide information to community groups on the steps required to obtain access to these funds.

Speakers from both central and local government will address the conference on funding avenues that can pursued by Irish groups through for example, the DSS, Home Office, Department of Environment, local authorities and Government Quangoes. Representatives from charitable

trusts will also be in attendance to provide information about specific trusts and there will be speakers to advise on the methods to use in identifying and targetting appropriate trusts for funding purposes.

In addition there will be speakers on applying to the EEC for funds and how private sector/business funding can be harnessed for the benefit of Irish community groups. There will also be opportunities for community groups to question the speakers at the conference.

### **DION Funding**

AGIY has learned that the DION Committee is currently considering funding applications from community groups with a view to announcing the allocation of its second round of grants in December 1989. The DION Committee has £500,000 at its disposal of which approx £250,000 has already been distributed.

### **Agency Profile**

This month AGIY features the work of Acton Homeless Concern which has recently received funding for the first time from DION the Irish Government Committee for Welfare Services Abroad.

The project which is situated in Emmaeus House was opened in November 1988 to provide a drop in centre in a welcoming and friendly environment for the homeless and the disadvantaged. A substantial number of Irish clients use the project's services.

#### **Facilities**

The building has been completely refurbished and now comprises a large room at the front where clients can have meals and a smaller room and kitchen also on the

ground floor. Upstairs there is a bathroom and a room for storing and distributing clothes, as well as an office and a consulting room.

#### Services

The project provides for a wide range of services to clients including free hot meals, bathing and hairdressing facilities and practical assistance in obtaining furniture.

In addition to this, a full time advice/advocacy/support worker is available to individual clients and to liaise with the Council, Department of Social Security and other agencies on their behalf.

On Wednesdays between 12 and 3.00 p.m. the project is open to women only and in addition to providing information and support, specific courses for women are organised. Counselling for alcohol abuse is also available on Tuesdays between 12 and 3.00 p.m.

The role of committed volunteers is crucial to the functioning of the project. Acton Homeless Concern is also involved in campaigning and group work and plans to develop a role as an access point to bring statutory services closer to the local community.

Opening Times: Tues. Wed. Thurs 12.00 - 3.00 p.m. Wed. is Women Only. Fri. and Sun. 12.00 - 2.00 p.m.
