EMIGRATION APRIL IMPACT HIGHLIGHTED

Preliminary results from the 1991 Census in the Republic of Ireland highlight the dramatic impact of emigration both on the national population and on local communities.

The Census indicates a net emigration loss of 136,486 persons between the previous 1986 Census and the 1991 Census.

- •The net estimated level of emigration amongst women was 61,100 or 44.7% of the total emigration figure.
- •For men, the estimates were 75,400 or 55.3% of the total.
- •When these figures are set against the 1986 population figures, they indicate that 3.85% of the total population has emigrated in this five year period.

They also highlight that emigration has impacted marginally more on men - at a level of 4.26% from the total male population since 1986. Amongst women, emigration has been at a level of 3.45% from the total female population since 1986.

The 1991 Census findings also confirm that in the 5 year inter-censal period, the average annual rate of emigration was at its highest for 35 years and this coincided with a period when the average natural increase (births) in the

Rep. of Irl. was at its lowest for 50 years. On a regional basis, the average annual rate of emigration was also at its highest since 1956 for the provinces of Leinster and Munster and no county achieved net immigration between 1986-1991.

Nonetheless, the Census highlights that the Rep. of Irl. continues to have a burgeoning youth population - the highest in Europe. The table below gives an age profile summary.

			though emigration is thought to

have slowed down recently, as a result of the depressed economies in the traditional destinations for Irish emigrants, Britain and America, it is expected that the exodus will substantially increase again before the end of the decade. When the results of the 1991 UK Census begin to be published, new data will emerge that will inform on the patterns of emigration from Ireland to Britain during the last decade 1981-1991 and on the experiences of the latest wave of Ireland's diaspora.

New AGIY Worker Appointed

As we go to press AGIY have just appointed a third worker to the newly created position of Training and Consultancy Worker within the organisation.

Martin Tucker who previously worked with the Travelling community as a social worker employed by Haringey Council will be joining AGIY at the end of May.

As Training and Consultancy Worker Martin will be responsible for promoting and developing an Irish dimension to agencies' equal opportunities work through the provision of training services and for developing a range of consultancy and training services for the Irish community and statutory and voluntary organisations at a local and national level in Britain.

Funding News

London Boroughs Grants Scheme

Irish voluntary organisations have been informed that they are to continue to receive funding from the London Boroughs Grants Scheme (LBGS) for the financial year 1992/93.

In decisions announced during the past few weeks Brent Irish Advisory Service (BIAS) will receive £10,190; CARA £110,885; London Irish Women's Centre £88,370 and the Action Group for Irish Youth £24,552.

While CARA received a small increase in its annual funding from the LBGS, the grants to the remaining groups were frozen at their 1991/92 levels.

The LBGS are currently in the process of considering longer term funding over three years for all groups which may also be of benefit to the Irish groups funded by the Scheme especially in terms of planning and stability.

ITV Telethon

The third Telethon will be broadcast live by ITV on 18th and 19th July 1992. All monies raised within the Thames/LWT area will be administered and distributed by the Thames/LWT Trust which is a registered charity.

Southwark Appoints Irish Policy Officer

The London Borough of Southwark has just appointed Patrick Reynolds as its first Irish Policy Community Liaison Officer.
Southwark has a large local Irish community and it will be part of Pat's job to progress issues of concern to the Irish community within the Council.

In November 1988 the Southwark Irish community held a Consultative Conference which made over 60 recommendations to Southwark Council for policy changes which would improve the lives of Irish people living in the Borough. Since then the Southwark Irish Forum has been instrumental in pursuing these recommendations with the Council and Pat said on his appointment that "my role wil be

to build upon this solid foundation in advancing Council wide policies to meet the needs of the large local Irish Community."

Shelter Nightline

Inside this edition of "AGIY-INFO" is a leaflet with information about Shelter Nightline.

Shelter Nightline is a free helpline for those in emergency housing need and operates from 6 pm to 9 am on weekdays and 24 hours over weekends.

The service provides practical help and advice and will assist callers with such problems as finding emergency temporary accommodation, illegal evictions, domestic violence and harassment, including racial harassment. The service also provides advice on a wide range of housing problems and callers will also be referred to day-time agencies for further assistance when appropriate.

Ann Doyle, the manager of the Nightline said that "the Nightline is committed to assisting the Irish Community in London and also to encourage take up of the service by travellers, lesbians and gay men and people with HIV."

Agency Profile

North Kensington Law Centre

North Kensington Law Centre was the first law centre to be established in the UK in 1970 and is run by a voluntary Management Committee comprising of local people and a full time Director. It currently has a staff complement of 14 workers and is open to the public daily from Monday to Friday between 10 am and 6 pm.

The Centre is a charity funded by a grant from the Legal Aid Board, Legal Aid income and additional funding from the Royal Borough of Kensington and Chelsea. It offers legal advice, representation, research, education and support to people and community groups who live or work in North Kensington.

At the time of the last Census in 1981 4.98% of the population resident in the Borough of Kensington and Chelsea were Irish by birth. At least 40,000 Irish people therefore were resident in the Borough. With the increased rate of emigration from Ireland to London over the past 10 years the number of Irish people living in the Borough has undoubtedly increased and the Law Centre now reports that in some areas of their work up to 40% of their clients are Irish.

AREAS OF WORK

Immigration and Nationality

The Centre provides advice on nationality, representation at immigration tribunals and apeals, deportation cases and related matters.

Employment

Representation in Industrial Tribunals, county court action for recovery of unpaid wages, employment law as it relates to racial and sexual discrimination, disability, equal pay, and health and safety.

Housing

Representation in court in possession proceedings, legal advice and representation of the homeless, legal advice and assistance in getting repairs done, on cases of harassment and illegal evictions, advice and assistance on racial harassment, advice and help to community groups and

tenants associations, with research, training and constitutions.

Crime/Policing

Representation of generally young people at police stations and on criminal charges, civil actions against the police, police complaints, suspensions from schools, educational talks, research and advice and representation for victims of violent crime at the Criminal Injuries Compensation Board.

The Centre operates a 24 hour emergency service for people detained by the police. This service can be contacted out of normal working hours by telephoning (081) 840 7000 and asking for page number 0737564.
