The Irish in Britain, because of numerical strength and characteristics such as shared history, cultural tradition, common ancestral origins, constitute the largest Ethnic Minority. However, despite experiencing discrimination and disadvantage in employment, health and housing, this has not been reflected in Equal Opportunities initiatives. An Irish dimension to equal opportunities has been conspicous by its absence. AGIY's Training Service is an initiative to redress this absence and the range of courses and programmes available will enable professionals who work with Irish people to deliver a more aware, sensitive and improved service.

AGIY offer courses on how to practically incorporate an Irish dimension for those professionals in both statutory and voluntary agencies who work with Irish people. AGIY Training courses look at areas such as:

- The Importance of Language
- Perceptions of the Irish
- Ethnicity, Race Relations, Law
- Discrimination and Disadvantage
- Anti-Irish Racism
- The Historical Context
- Key Dates in Irish History
- Emigration
- Experience of Irish Emigrants
- An Irish Dimension Practical Implications

All courses include practical exercises on incorporating an Irish dimension and on improving work with and service delivery to Irish people. Training methods include presentations with OHPs and flipcharts, video and groupwork.

TRAVELLERS

Irish Travellers have been coming to Britain for over 100 years, yet they remain a misunderstood and marginalised group. Travellers experience a pervasive prejudice resulting in widespread discrimination and disadvantage. Travellers see themselves as an ethnic group in their own right, with their own language, culture, history etc. For those who work with, or come into contact with Travellers, AGIY can offer a course on Working with Travellers. Topics covered include:

- Perceptions of Travellers
- Myths and Reality
- Who are Travellers?
- History and Origins
- Anti-Traveller Prejudice
- Social and Cultural Lifestyle

plus exercises on improving work with and sevice delivery to Travellers.

All participants on AGIY Training Courses and Programmes will receive a comprehensive Information Pack containing handouts on all topics covered, together with data on the Irish community and contacts list.
